Dear Senator Heitkamp,

I am advocating for the establishment of a full time Vet Center in Grand Forks County. The need is present given our current veteran population, active duty military presence at Grand Forks Air Force Base and our Army National Guard units.

Vet Centers across the country provide a broad range of counseling, outreach, and referral services to combat veterans and their families. They are located in the following counties (cities) in North Dakota based on population size; Cass (Fargo), Burleigh (Bismarck), and Ward (Minot). Currently, one does not exist in Grand Forks.

Grand Forks County qualifies and must be added to this list. Veterans living in Grand Forks and the surrounding areas will substantially benefit from the Veterans Administration establishing a center here.

Vet Centers guide Veterans and their families through many of the major adjustments in lifestyle, often occurring after a veteran returns from combat. Services are free of cost and strictly confidential. Vet Center services may include:

- Individual and group counseling for veterans and their families in areas such as Post Traumatic Stress Disorder
- Bereavement counseling for families who experience an active duty death
- Military sexual trauma counseling and referral
- Substance abuse assessment and referral
- Screening and referral for medical issues including traumatic brain injury, depression, etc.
- Suicide prevention referrals

I would appreciate your support of this activity and have included several letters of support from our County Commissioners, City Mayor, and surrounding County Veteran Service Officers.

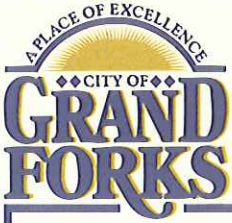
Additionally, partnering with our nearby counties will prevent veterans residing near Grand Forks from traveling great distances for vital assistance.
